

## **UTOPIAN BALL RAFFLE 2025 – OFFICIAL RULES AND DISCLOSURES**

**Sponsor:** The Utopian Ball Raffle 2025 (“Raffle”) is sponsored by Collaboraction Theatre Company, an Illinois nonprofit organization recognized as a 501(c)(3) public charity (EIN:36-4282304), with principal offices in Chicago, Illinois.

**Eligibility:** Open only to legal residents of Illinois who are 18 years of age or older at the time of entry. Employees, board members, and immediate family members of Collaboraction Theatre Company are not eligible. Void where prohibited by law.

**Entry Period:** Begins upon ticket availability and ends at 9:00 PM Central Time on November 15, 2025. Entries received after the deadline will not be included in the drawing.

**How to Enter:** Tickets may be purchased online or in person through authorized Collaboraction representatives. Ticket prices: 1 ticket for \$50; 3 tickets for \$100; 9 tickets for \$250; 20 tickets for \$500. Each ticket constitutes one entry. No purchase necessary where prohibited.

**Drawing:** The winning entry will be selected in a random drawing conducted by Collaboraction on November 15, 2025, at approximately 9:30 PM CST at the Utopian Ball held at Venue West, 221 N. Paulina Street, Chicago, IL. The winner need not be present to win. The decision of Collaboraction is final and binding in all respects. The winner will be notified by phone and/or email within five (5) business days following the drawing.

**Prize:** One (1) Grand Prize will be awarded. The prize consists of a luxury travel package to Maui, Hawaii, with an estimated retail value of \$25,000, including two (2) first-class round-trip tickets on United Airlines; a seven-night stay in the four-bedroom, four-bathroom Big House at Hua Momona Farm with private pool, hot tub, and panoramic views; and a private farm tour and sunset toast.
